श्री बाल कुमार (एन) श्री Bal Kumar Patel, MP(Lok Sabha) forwarded the representation from the villagers of Devhat, Mahugadi, Bhaissaud Valaya Pahar, Lahuriadeh etc. in Mirzapur district who worked under the Mahatma Gandhi National Rural Employment Guarantee Act but not paid wages. Accordingly, Shri M S Yadav, National Level Monitor was deputed to district Mirzapur to look into the allegations made in the representation. I am enclosing a summary table of investigation conducted by Shri Yadav on 27<sup>th</sup>-31<sup>st</sup> January 2010 for information.

2. You are requested to provide the following information at the earliest.

- (a) Balance payment of wages indicated at S.No.2 and 6 paid or not.
- (b) Comments in respect of S.No.3 and 7

3. As the reply to the Shri Patel is getting delayed, I shall appreciate if urgent action is taken in the matter and information/comments furnished.
